Supervisor Stowell called the meeting to order at 6:39pm, he then led in the Pledge of Allegiance to the Flag.

Minutes of 07/13/04: Motion made by Councilor Sheeley seconded by Councilor Stowell to accept the minutes as written. Motion carried. Adopted (3-0) Councilor Sheeley: aye, Councilor Stowell: aye, Councilor Barker: aye.

Reports: 1) Terry Walker, DCO: Mr. Walker reported the following: a) The dogs on Sheepskin Rd have food on the steps but no water, the town is only liable for the dogs to have up to date rabies shots. b) The dog enumeration is going but slow. C) He has the quotes in for the dog shed's with the place in Sandy Creek being the lowest. He would bring the information to Supervisor Stowell by the weekend. D) Mr. Walker stated five dogs were put down; he would check with the Adams Veterinary Clinic about prices for euthanasia/cremation. E) He would bring what paperwork he has on the enumeration to Mrs. Ford later.

- 2) Howard Allen, Town Justice: Supervisor Stowell read the report Judge Allen submitted for July 2004.
- 3) Denise Trudell, Sole Assessor: Supervisor Stowell stated he had received word from the State Dept. of Real Property that the town's equalization rate is at 100 %, and the 2004 re-assessment aid has been received. Mrs. Trudell stated she would like to attend the fall conference in Hudson Valley October 3rd 6th. The cost of the hotel and registration fee would be added to general abstract #8 of 2004.
- 4) Vern Mowers, CEO: Mr. Mowers submitted his report and he reported the following: a) Mr. Bruce Mathis has his permit and is all set, and the work has already started. b) The changes on the template for update of the local law would be e-mailed to Supervisor Stowell, so he could forward it on. c) Mr. Carl Bice has changed his business name to Scrap Metal Brokers of Upstate NY, Inc., and all the paperwork Mr. Mowers has seen states Mr. Bice owns the business. Supervisor Stowell then read a complaint letter from the Os. Co. Dept. of Transportation to Mr. Bice regarding vehicles parked outside his business along State Route 13 that are in violation of the States Vehicle & Traffic Law. The board present all agreed that they didn't have a problem with Mr. Bice obtaining his junkyard permit.
- 5) Emil Wells Jr., Hwy Supt.: Mr. Wells submitted his asset inventory list, and reported on the following: a) Highway Specifications & Requirements: only change would be to plastic pipes. He gave Supervisor Stowell a copy of the Town of Redfield's spec's to review. b) Os. Co Solid Waste is now charging for everything. There are no dump stickers on any of the town trucks. The cost to obtain one would be\$50.00 for the first truck and \$20.00 for any additional truck. c) The FCC has cancelled the license due to non-payment. d) The paving is done; the sealing is almost done. e) He has given the Village Hwy workers the O.K. to take any grindings the town got free from I81 to fix the Village streets. f) The Army truck is down, it needs to be replaced. Mr. Wells would get an estimate on how much it would be to fix. g) The Hwy office is ¾ completed; the stairs would be fixed next year. Supervisor Stowell stated that he and Mr. Wells has met with a Stadium International representative, if the town could get a better deal, they would purchase a new truck. Supervisor Stowell also stated that he had received a re-negotiation letter from Teamster Local #687, the board would meet with the Teamster's rep and with the Hwy workers on August 26th at 5pm. Supervisor Stowell then asked Mr. Wells if he was interested in the Cornell Local Roads seminars? Mr. Wells stated he was interested in two the "Ice & Snow Control" and "How to Handle People".
- 6) Fire Dept.: Supervisor Stowell gave the board the monthly fire calls for July 2004 to review.

- 7) Pre-K: An ad for a Pre-K Director was placed in the paper 07/28/04, to run for two weeks. Only two people responded, Mrs. Hanna J. Weigel & Mrs. Christa Oakes. Mrs. Ford would give the resumes' to Mrs. Becky Mullin, President of the Pre-K Parent Group.
- 8) Amy J. Ford, Town Clerk: For the month of July 2004 total disbursed was \$981.00. The town received for the general fund \$130.70 and \$710.00 for the part town fund. Os. Co. Treasurer received \$89.30 and the NY State Dept. of Ag. & Markets received \$51.00. Mrs. Ford submitted her phone log and her petty cash is at \$25.00. Mrs. Ford also reported that she received a letter from the Os. Co. Board of Elections regarding an Emergency Plan for the upcoming fall elections, in case there is a disruption in voting. Motion made by Councilor Stowell seconded by Councilor Barker to accept the report as stated. Motion carried. Adopted. (3-0) Councilor Sheeley: aye, Councilor Stowell: aye, Councilor Barker.
- 9) Frederick Stowell, Supervisor: Motion made by Councilor Sheeley seconded by Councilor Barker to accept the report as read by Supervisor Stowell. Motion carried. Adopted. (3-0) Councilor Sheeley: aye, Councilor Stowell: aye, Councilor Barker: aye. Fund balance sheets and revenue reports were also handed out.
