Proof of Notice having been furnished, the Public Hearing on amending Local Law # 1 of 2003 "ATV Law" was called to order at 6:31pm by Frederick Stowell, Supervisor.

Mr. Steve Cronk, President of the Os. Co. ATV Club stated that the roads in the Town of Richland also include the Village of Pulaski.

Supervisor Stowell stated that the roads the Os. Co. ATV Club request to be open only connects the existing trails.

Mr. Charles Sperling, Hwy Supt. stated that he has had complaints from landowners on Main St. regarding the dust stirred up by the ATV's. He stated that he would need to put down calcium to help cut the amount of dust. Also, Mr. Sperling stated that Austin Rd would need to be graded because of the ATV's turning up the gravel road.

Mr. Steve Cronk, President of the Os. Co. ATV Club stated that on Main St., the local use of cars and motorbikes also cause the dust to fly not just the ATV's. Also, on Austin Rd, he has talked with the owner who lives on the end and has asked him and his family not to tear up the road with their ATV. Mr. Cronk then stated that the DEC would be policing the area trails more.

Councilor Eldred asked if only ATV's were allowed on the trails, no dirt bikes? Supervisor Stowell stated the only ATV's were allowed.
