Supervisor Stowell called the meeting to order at 7:30pm, followed by the pledge of allegiance to the flag. Minutes of 10/16/07: **Motion made by Councilor Sheeley seconded by Councilor Eldred to accept the minutes as written. Motion carried. Adopted (5-0) Councilor Sheeley: aye, Councilor Stowell: aye, Councilor Barker: aye, Councilor Eldred: aye, Supervisor Stowell: aye.**

**New Business:** 1) Mrs. Deborah Haab, A.P.W. Superintendent of Schools presented the board with copies of the "Shared Services" information. Supervisor Stowell stated that further discussions with this topic would be beneficial to all.

**Reports:** 1) DCO: There will be a Public Hearing on December 13<sup>th</sup> at 6:30pm before the regular meeting on the proposed Local Law # 2 of 2007 amending Local Law # 1 of 1990. This would be the new Dog Control Law.

2) Vern Mowers, CEO: Mr. Mowers submitted his report from 10/01/07 to 11/12/07. Ms. Heather Davis requested a variance to bring a 1985 14'x70' Champion mobile home to her property at 576 Hong Kong Rd from Sandy Creek. This would be hooked to the existing utilities if possible; Mr. Mowers would check the mobile home out. **Motion made by Councilor Eldred seconded by Councilor Sheeley to allow the variance only if Mr. Mowers checks it out and gives the ok. 3) Milferd Potter, Os. Co. Legislator: Mr. Potter reported the County is going over their budget. As of now, there is a 10.5% decrease. Also, the Pineville Bridge has been red flagged due to broken bolts and nuts.

4) Paul Baxter, Tug Hill Circuit Rider: Mr. Baxter stated that the next meeting of the Salmon River Council would be on 11/26/07, this was agreed on at last months meeting. Supervisor Stowell stated that the Tug Hill Health Insurance survey was quite informative. Mr. Baxter would get back on setting up a training session here for the Planning Board regulations.

5) Howard Allen, Town Justice: Supervisor Stowell read Judge Allen's report for October 2007.

6) Hwy Supt.: Working Foreman Wayne Kaminsky gave the following report on Mr. Sperling's behalf:
