Municipal Water Engineering Studies: Supervisor Walter stated he had asked the surrounding Town Supervisor's for information on the costs they are paying for their water. The Town of Richland has one water district that is almost as high as the proposed cost for Albion. The Town of Orwell has a cheaper rate since it has a down-hill flow. The Town of West Monroe has different broken down costs that total around \$410/year. Supervisor Walter stated that the next step would be the Engineering Study which would still be within the grant funds. Voting for the next step will be tabled until January's meeting.

CBDG Grant – request for funds: Deputy Supervisor Lonny Mattison needs to sign the form and Supervisor Walter would send it in. This is to re-coup money that was spent this year.

Public Comment: 1) Mr. Baxter asked when the Organizational Meeting would be held. Supervisor Walter stated it would be on Tuesday, January 10<sup>th</sup> at 6:30pm with the regular monthly meeting to follow.
